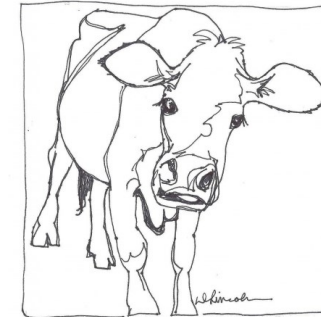

Decisions are all around us, and this year is no exception to the rule. This year we have had the most significant changes in regards to the legislation for Implements of Animal Husbandry (Act 377) and the Farm Bill. As you will tell from reading through this newsletter, we have many upcoming meetings which mean more decisions for you to make in regards to how you will spend your time.

Some of the most significant decisions you will need to make for your farm operation are in regards to the Farm Bill. Elections for the Dairy Margin Protection Plan (DMPP) and the crop programs (ARC or PLC) may send your mind reeling; however, an upcoming meeting on December 12th in Lena may help you make informed decisions about crop coverage. If you are unable to commit to the December 12th meeting, more informational sessions about crop coverage will be hosted at the beginning of next year. If you have unanswered questions about DMPP, please feel free to call me as I would be happy to provide you with information.

As we approach the beginning of a new year, you may be re-evaluating your current operation in regards to expansion or employee training. Two noteworthy programs to draw your attention to in this newsletter would be the Dairy Modernization Meeting held in Green Bay on January 8th and Managing Dairy Employees Effectively, a bilingual two-day dairy manager training held in three different locations. Please note the deadlines for these events are quickly approaching, so take a minute to send in your completed registration.

Implements of Husbandry Producer Informational Session

What do the new Implements of Husbandry laws really mean for you as a producer, custom operator or anyone else driving agricultural machinery on public roadways?

Farm Service Agency Crop Program Information Meeting

December 12, 2014, 1:00PM

The December 12th meeting will review acre and yield updating procedures, but will also include the decision-making process that all crop producers need to make regarding which program to sign their acres into—PLC or ARC. If you are unable to attend the December session, more informational sessions will be hosted in January and February of 2015.

Farmland Rental Options Workshop

This annual workshop is recommended for owners of rented land. The focus is on land rent realities and options that can make land rental situations better for all parties involved with the emphasis on crop production economics.

The session is free and will be held on Tuesday, December 16, starting at 6:30 p.m., at the Oconto Falls Community Library, located at 251 N. Main St. (Hwy. 22). Discussion will focus on the details that you should consider when negotiating a farm rental contract. Such details certainly include price, but other factors such as length of lease, any limitations you may place on the property, and many other aspects can all be negotiated into the contract. There are also many different leasing options available and Reuss will detail some of the advantages and disadvantages of different types of annual or multi-year leasing contracts.

Contract templates of multiple types will be available as handouts, ranging from extremely simple to more complex arrangements. The discussion will focus on basic cropland rental situations, but can expand to building leases, grazing land, and other situations which attendees are interested in discussing.

Dairy Modernization Meeting “Building Our Dairy Future”

Thirty years ago, what was considered “dairy modernization” typically was adding stall at the end of the barn. Today, it describes major capital investments involving not just construction and cows, but permits, licenses and finances.

Dairy modernization is a long-term commitment, both personally and financially. Join us as we navigate through the water for a dairy modernization project that will help build your dairy future and set you on the road to success.
